

8.4 Library Content.

(A) A law school's law library must contain the following law library material:

2. <u>Dictionaries</u> A legal dictionary and A general dictionary	Require both in h Hard copy.
3. <u>Annotated Reports</u> American Law Reports – Federal American Law Reports, 4th and 5th	Require all in h Hard copy <u>or</u> <u>online access.</u> It is recommended that online access be provided for American Law Reports 1st through 3rd.
4. <u>American Law Institute Publications</u> Model Codes, Reports and Drafts Restatements of the Law, Reports and Drafts	Require all in h Hard copy. <u>or</u> <u>Online access is an</u> acceptable alternative. Require in hard copy for all required courses in the law school's curriculum; online access is an acceptable alternative for all other courses.
5. <u>Forms of Pleading and Practice and Legal Forms</u> California Judicial Council forms Current set of California forms Current set of National <u>Federal</u> forms	Require both in h Hard copy <u>or</u> . Require all in hard copy. Online access is an acceptable alternative.

Both official and unofficial in hard copy are recommended. <u>Unofficial reporters, hard copy or online access</u> Require all in hHard copy. <u>[alternative of online access proposed, but no consensus reached]</u> <u>Online access</u> Require all in hHard copy. or Online-online access is an acceptable alternative.

9. <u>National Reporter System</u> (1st to date) for all of the following: Atlantic Reporter, New York Official Reports Northeastern Reporter Northwestern Reporter Pacific Reporter Southeastern Reporter Southern Reporter Southwestern Reporter	Require all in h Hard copy — or Online-online access is an acceptable alternative.
10. <u>Text and Treaties</u> Encyclopedia, treaties, or current text for courses taught Witkin, Summary of California Law Witkin, California Procedure Witkin, California Criminal Law Witkin, California Evidence	Require all in H hard copy .
11. <u>Law Reviews and Journals</u>	Require eight in hard copy. The law school must select have access to at least eight publications or topical journals that are most suitable for its curriculum and its students. These materials must date back to 1970. Hard copy or Online access is an acceptable alternative. [Consensus was not reached as to whether there should be a number, and if there is a number, what number that should be.]
12. <u>Other Resources</u> Current Law Index or Index to Legal Periodicals Local county and city ordinances Local municipal codes Legislative history-United States Code,	Require all in h Hard copy or. Online-online access is an acceptable alternative.

13. <u>Cite Checking Resources</u> Shepard's Citation Service or Westlaw Key Cite	Require one in hHard copy or, Oonline access is an acceptable alternative.

- (B) Whenever a set of books is specified, the requirement includes the most recent version, although it may not be listed, and reasonable access to:
- (1) All supporting materials published as part of the set, and the latest available pocket parts, supplementary and replacement volumes, and any other materials necessary to keep the set in current condition; and
 - (2) All periodicals, in permanently bound form, except for the current year.
- (C) For material that may be provided online, the law library must have a reasonable number of computers and printers available for student and faculty use in accessing and printing it.
