Questions Specific to the Bar Cards

Is it 2 PMS colors plus black pre-printed on the face and black only on the back or are there PMS colors on the back of the card as well?

On the front of the Bar card there are 2 pms colors and black. On the back of the card there is 1 pms color and black. Please note the data printed with the PMS colors involve static information and the black requires variable data imaging.

Are the Photo ID Bar Cards for Year 2 and Year 3 to be imaged in black or 4 color process thermal imaging?

Please provide quotes for both black and white and color pictures.

Is it possible to review the electronic samples of the Photo ID Bar Card identified in Section E?

There are no electronic samples of the Photo ID Bar Card, as this card has not been made available to the membership. The design of the photo bar cards will be collaboration between the vendor and the State Bar. We regret any inconvenience caused by stating that it was possible to provide a copy of a photo bar card for your review.
