## ANTITRUST DETERMINATION 2024-0001

### AUTHORITY

This determination is made pursuant to California Supreme Court Administrative Order 2017-09-20 (State Bar Antitrust Policy), which mandates that the State Bar Office of General Counsel (OGC) provide a determination on whether State Bar actions raise potential antitrust concerns.

### ISSUE PRESENTED

Between August 30, 2024 and September 24, 2024, Devin Wade (Requestor) submitted five Requests for Antitrust Determination (Requests), utilizing the State Bar's form, available at [https://www.calbar.ca.gov/Portals/0/documents/forms/Request\\_for\\_Antitrust\\_Determination.pdf](https://www.calbar.ca.gov/Portals/0/documents/forms/Request_for_Antitrust_Determination.pdf).

In his Request submitted on August 30, 2024 at 5:04 p.m., Requestor alleges that laws on the website [law.cornell.edu](http://law.cornell.edu) "are being changed so I cannot defend myself...after Dept of Defense, NSA & FBI tries framing me for my domain name(s),/intellectual property," that the Central District of California is "filing civil suits behind my back...and dismissing my civil suits [due] to deficiencies and not getting in contact with me," that President Biden is "passing laws & changing laws...to take my life," that courts have engaged in perjury and conspiracy against Requestor's rights, and that the Department of Defense and NSA are changing Requestor's email passwords.

In his Request submitted on August 30, 2024 at 5:51 p.m., Requestor alleges that a clerk is not filing his civil suits, such as Devin Wade v. Riverside County Sheriff's Department and Devin Wade v. Central District of California, and that President Biden "is allowing this to go in and supports a civilians life to be taken by Dept of Defense and NSA."

In his Request submitted on August 30, 2024 at 8:35 p.m., Requestor alleges that "everything I've filed with Central District of California the nature of suit has been RICO/CORRUPT ORGANIZATION, which was not how [I] filed and each one was said to have deficiencies [but] these are out right lies," that the Department of Defense, FBI, and NSA are "hacking me...in contact with central district of California filing and plotting to kill me," and that the "government [has] been framing me for past 8 years for my domain names" and "falsifying and concealing documents."

In his September 18, 2024 Request, Requestor alleges that “he is going to trial and pretty sure that my attorney...is not going to file any of the evidence with discovery which would be perjury.”

In his September 24, 2024 Request, Requestor alleges that in the “case of THE PEOPLE OF THE STATE OF CALIFORNIA v. Devin Kyle Wade (case # 24WCCM00228) out of West Covina Court House documents are not being filed via Public Defender Jay Factor nor has he returned an email or phone call” in violation of 18 U.S.C. section 1505, which prohibits obstruction of compliance with a civil investigative demand issued under the Antitrust Civil Process Act. Requestor further asserts, “I see corruption is being egged on and my rights of life not upheld.”

Requestor’s email submissions in support of his Requests, including all of his Request for Antitrust Determination forms, are attached to this determination as Appendix 1.<sup>1</sup>

## ANALYSIS

### REQUESTOR MAKES NO ALLEGATION REGARDING ACTIONS BY THE STATE BAR

The State Bar Antitrust Policy mandates that OGC must determine “whether a proposed or current *State Bar* course of action implicates antitrust concerns.” (State Bar Antitrust Policy at p. 3, italics added.) Requestor makes allegations regarding the actions of courts, federal agencies and officials, and his public defender. He makes no allegations regarding proposed or current actions of the State Bar. These Requests thus do not raise the possibility that an action by the State Bar implicates antitrust concerns.

### THERE IS NO PLAUSIBLE CONNECTION BETWEEN THE ALLEGED CONDUCT AND THE EFFECTS ON COMPETITION IN THE LEGAL MARKET NECESSARY TO IMPLICATE THE ANTITRUST LAWS

As set forth in the State Bar Antitrust Policy, the antitrust laws are implicated if the State Bar conduct at issue “has an effect that could impact competition or could be an unreasonable restraint of trade in the market for legal services.” (State Bar Antitrust Policy at p. 3.) Unreasonable restraints of trade involve conduct resulting in increased prices for goods or services, reduction in output, diminished quality, reduced choices, or the creation, maintenance or enhancement of market power in a relevant market. (*Id.*) If the conduct “does not affect competition or only has a de minimis impact, the antitrust laws are not implicated.” (*Id.* at p. 4.)

Requestor alleges that laws are being changed to disadvantage him in various legal actions, that the Department of Defense, NSA, and FBI are framing him for his “domain names,” “hacking” him, and engaging in other misconduct, that a federal court is rejecting his court filings and

filing suits against him “behind [his] back,” and that his public defender is not going to submit evidence and documents he believes should be submitted in legal cases against him. Requestor makes no allegation that any of this conduct affects competition in the legal services market or any defined relevant market. Indeed, even if Requestor’s allegations could be substantiated (an undertaking beyond the scope of this Antitrust Determination), there is no plausible connection between the alleged conduct, which relates exclusively to purported conspiratorial transgressions against and criminal and civil legal actions involving only the Requestor, and increased prices or any other indicator of anticompetitive effects in any market.

While Requestor also alleges that his public defender violated a federal statutory prohibition against obstructing compliance with a civil investigative demand in an antitrust investigation, he does not actually allege that he or his public defender are in any way connected to an antitrust investigation, let alone to an investigative demand served in such an investigation. Nor does he explain how the alleged conduct, his public defender’s failure to file documents in a presumably criminal case against Requestor, could conceivably violate a prohibition on obstruction of compliance with a civil investigative demand in an antitrust matter.

## CONCLUSION

Based on the foregoing analysis, Requestor has not alleged or described any State Bar actions that raise potential antitrust concerns.

## REVIEWABILITY

OGC’s determination of potential antitrust violations may be reviewed *de novo* by filing a petition with the California Supreme Court, pursuant to California Rules of Court, [rule 9.13 \(d\)-\(f\)](#), within **60 days of the date of this determination**. (State Bar Antitrust Policy, p. 3.)
